इस सूचना का सन्दर्भ 6 अलग-अलग आईटीआई ट्रेडों में अपरेंटिस शिक्षुओं के कुल 1140 पदों को भरने के लिए संदर्भ संख्या एनसीएल/एचआरडी/आईटीआई ट्रेड अपरेंटिस/अधिसूचना/2023-24/4038, दिनांक 27/09/2023 द्वारा प्रकाशित अधिसूचना है, जिसके द्वारा ऐसे उम्मीदवारों से जो पात्रता के अधिसूचित मानदंड को पूरा करते हैं, ऑनलाइन माध्यम से आवेदन आमंत्रित किए गए थे, ऐसे सभी उम्मीदवारों को सूचित किया जाता है कि ऑनलाइन माध्यम से कुल 20076 आवेदन प्राप्त हुए थे, जिनमें से कुल 3262 उम्मीदवारों को नोटिस सन्दर्भ संख्या एच-238, दिनांक 26/11/2023 के तहत उनके मूल दस्तावेजों की सत्यापना के लिए शॉर्टलिस्ट किया गया जिसमें कुल 1753 उम्मीदवार स्कूटनी प्रक्रिया में सम्मिलित हुए।

This has reference to the Notification published vide reference no NCL/HRD/ITI Trade Apprentice/Notification/2023-24/4038, dated 27/09/2023, for filling the 1140 positions of Apprentice Trainees pertaining to 6 different ITI Trades wherein online applications were invited from such candidates who fulfill the notified criterion of eligibility, all such candidates are hereby informed that a total of 20076 applications received online out of which a total of 3262 candidates were shortlisted for scrutiny of their original documents vide Notice H-238, dated 26/11/2023, and a total of 1753 candidates attended the scrutiny process.

गहन जांच प्रक्रिया के परिणामस्वरूप चयन समिति ने 6 अधिसूचित ट्रेडों के लिए अलग-अलग मेरिट पैनल के अंतर्गत कुल 1140 रिक्ति के सापेक्ष '954' उम्मीदवारों की अनंतिम रूप से सिफारिश की है और वर्तमान में कुल 186 पद रिक्त है। अनंतिम रूप से अनुशंसित योग्यता पैनल को इस नोटिस के साथ 'अनुलग्नक-ए' के रूप में प्रस्तुत किया गया है।

As an outcome of the intense scrutiny process the Selection Committee has provisionally recommended '954' candidates falling under the Merit panel for 6 notified Trades and against the total vacancy of 1140 leaving 186 unfilled positions. The provisionally recommended merit panel is hereby produced with this notice as 'Annexure -A'.

ऐसे सभी उम्मीदवार जो मूल दस्तावेजों की सत्यापना की प्रक्रिया में शामिल नहीं हुए हैं, अधिसूचना के प्रावधानों को पूरा न करने के कारण उनकी उम्मीदवारी रद्द कर दी गई है और ऐसे सभी '1509' उम्मीदवारों को इस नोटिस के साथ प्रकाशित 'अनुलग्नक-बी' के तहत रखा गया है।

All such candidates who have not attended the scrutiny process their candidature is cancelled for non-fulfillment of the provisions of the notification and all such '1509' candidates are placed under '**Annexure-B**' published hereby along with this Notice.

शेष '799' उम्मीदवार जो मूल दस्तावेजों की सत्यापना में सम्मिलित हुए थे, लेकिन अनंतिम रूप से अनुशंसित मेरिट पैनल जो अभ्यर्थियों के स्कोर पर आधारित है उसमें सम्मिलित नहीं है अथवा उन्हें उनके नाम के समक्ष दर्शाये गए कारण से रिक्ति के अयोग्य पाया गया है, अथवा वो जिन्हें प्रतीक्षा सूची में या होल्ड स्थिति में रखा गया है, उन्हें नोटिस के साथ प्रकाशित 'अनुलग्नक सी' के तहत रखा गया है।

The remaining '799' candidates who have attended the scrutiny but could not be placed under Merit following their scores have been placed under '**Annexure C**' published herewith the Notice. 'Annexure C' contains the name of all such candidates whose candidature is either rejected for the reasons mentioned against their names or who are kept on hold.

चूंकि एमएल-2 उम्मीदवारों को केवल वेल्डर और मोटर मैकेनिक ट्रेडों के लिए शॉर्टलिस्ट किया गया था, ऐसे एमएल-2 उम्मीदवार जिन्हें मेरिट के तहत रखने के लिए अनंतिम रूप से अनुशंसित नहीं किया जा सका, उन्हें प्रतीक्षा में रखा गया है।

Since the ML-2 candidates were shortlisted only for Welder & Motor Mechanic Trades such ML-2 candidates who could not be provisionally recommended to be placed under Merit are kept under Waiting.

हालाँकि, शेष ट्रेडों इलेक्ट्रॉनिक मैकेनिक, इलेक्ट्रीशियन और फिटर के लिए एमएल-2 से संबंधित उम्मीदवारों को होल्ड स्थिति के तहत रखा गया है क्योंकि एमएल-2 उम्मीदवारों को मूल रूप से नहीं बुलाया गया था और जांच प्रक्रिया के बाद ही उम्मीदवारों को एमएल - 2 के अंतर्गत आने की पुष्टि की गई थी जबकि ऑनलाइन आवेदन के तहत उनके दावों के बाद उन्हें एमएल-1 के लिए शॉर्टलिस्ट किया गया था।

However for the remaining trades that are Electronic Mechanic, Electrician & Fitter candidates belonging to ML-2 are placed under Hold Status because ML-2 candidates were not called originally and it is only after the scrutiny process that candidates were confirmed for falling under ML-2 whereas they were shortlisted for ML-1 following their claims under online application.

इसके अलावा यह भी सूचित किया जाता है कि ऑटो इलेक्ट्रीशियन ट्रेड के ट्रेड अपरेंटिस पद के लिए आवेदन करने वाले सभी उम्मीदवारों को बुलाया गया था और उनमें से कोई भी मूल दस्तावेजों की सत्यापना हेतु उपस्थित नहीं हुआ है, इसलिए अधिसूचना के प्रावधानों का पालन न करने के कारण ऐसे सभी उम्मीदवारों की उम्मीदवारी रद्द कर दी गई है।

Further this is also informed that all the candidates applied for the Trade Apprentice position of Auto Electrician Trade have been called and none



have appeared for scrutiny hence the candidature of all such candidates is hereby cancelled for non-compliance of the provisions of the Notification.
